3) N ( On January 14, 2020, at 8:30 a.m., the Ex Parte Application for Temporary Restraining
 Order (TRO) and Order to Show Cause Re Preliminary Injunction filed by Petitioner CITRUS
 ST PARTNERS, LLC came on for hearing in Department 66 of the above-entitled court. The Ex
 Parte Application having been fully argued and considered and proof being made to the
 satisfaction of the court that Petitioner has satisfied all requirements necessary for issuance of an
 OSC re Preliminary Injunction and TRO:

7 IT IS HEREBY ORDERED that Respondents CITY OF LEMON GROVE and CITY
8 COUNCIL OF THE CITY OF LEMON GROVE (collectively, "City") be ordered to show cause
9 why a preliminary injunction should not issue enjoining the City and their respective agents,
10 instrumentalities, and assigns from taking any action, discretionary or ministerial, that would
11 disturb, extinguish, interfere with, or otherwise prejudice Zoning Clearance ZCM-180-0005 until
12 the resolution of the underlying litigation.

The following deadlines shall apply with respect to the OSC:

- The hearing on the OSC Re Preliminary Injunction shall be held on February 14, 2020 at
   10:00 a.m. in Department 66 of the above-entitled Court.

  2. Respondents' opposition papers shall be filed on or before 5:00 p.m. on January 30, 2020
  and shall be served electronically via One Legal at the time of filing.

  3. Kim Investments, LLC's intervention and opposition papers shall be filed on or before
  5:00 p.m. on January 30, 2020 and shall be served electronically via One Legal at the
  time of filing.

1	IT IS HEREBY FURTHER ORDERED that a Temporary Restraining Order (TRO)
2	binding on Respondents CITY OF LEMON GROVE and CITY COUNCIL OF THE CITY OF
3	LEMON GROVE shall issue as follows:
4	1. To prohibit Respondents and their respective agents, instrumentalities, and assigns from
5	finally approving conditional use permit CUP-190-0002 to establish a medical marijuana
6	dispensary at 3515 Harris Street, Lemon Grove, California until a final determination on
7	the OSC Re Preliminary Injunction.
8	2. To further prohibit Respondents and their respective agents, instrumentalities, and assigns
9	from issuing any building permits or certificates of occupancy for a day care facility at
10	3468 Citrus Street, Lemon Grove, California until a final determination on the OSC Re
11	Preliminary Injunction.
12	The TRO shall expire at the time the Court issues a final Ruling on the Order to Show Cause
13	Re Preliminary Injunction.
